*The undersigned Parents/Guardians hereby enroll the above named student in The Lake Norman Learning Center (LNLC) for the 2012-2013 school year. By affixing your signature(s) to this document, you have read and accepted the terms and conditions of enrollment at the Lake Norman Learning Center.*

- 1. LNLC has granted to each student one of a limited number of placement positions. The Parents/guardians agree their obligation to pay the full tuition and any fees for each student is unconditional and for the full school year, no portion of such tuition or fees paid or outstanding will be refunded or cancelled in the event of absence, withdrawal or dismissal of the student from LNLC for any reason.*
- 2. The Parents/Guardians understand and agree that enrollment in LNLC for the 2012-2013 school year does not guarantee continued enrollment. LNLC reserves the right to dismiss a student at any time during the school year if the general conduct, attitude or actions of the student or his/her parents/Guardians, interfere with the health, safety, or educational development of the student or any other students or are contrary to the interest of LNLC.*
- 3. LNLC has the right to withhold any and all services to the student until student's account has been paid in full. In the event that LNLC finds it necessary to place this Agreement or any other dept owed with a collection agency or attorney, the Parents/Guardians agree to bear all court cost and reasonable collection/attorney's fees, plus interest at the maximum rate allowed by law.*
- 4. All payments not received by the 1st of each month in which they are due will incur a late fee of \$25.*
- 5. Enrollment is complete upon receipt of signed tuition contract and first payment.*
- 6. The Center reserves the right to use photographs and/or videos in school publications and advertisements designed for the sole purpose of promoting The Lake Norman Learning Center. We waive all rights to the aforementioned without compensation or further consideration.*

**Release and Hold Harmless**

*\*This release and hold harmless Agreement is executed this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_ by and between The Lake Norman Learning Center ("LNLC") and the child whose name is printed below, together with his/her parent or legal guardian (the "Participant").*

*In consideration of being permitted to enter and use the grounds and other facilities of the LNLC; and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Participant hereby agrees to the following terms:*

*Participant hereby releases, waives and discharges LNLC, its officers, directors, employees, volunteers or teaching staff, and each of them from any and all liability to Participant for any and all loss or damage to Participant on account of injury to the Participant or the Participant's personal property, while the Participant is participating in any of the activities sponsored or conducted by LNLC.*

*Participant further agrees to indemnify LNLC for any loss, liability, damage or cost that LNLC may incur due to any harm suffered by the Participant. Participant agrees to never institute suit or action against LNLC for damages, cost, expenses, or loss of services resulting or arising from any such loss, damage or injuries.*

*Participant acknowledges that he/she is financially responsible for any medical cost related to any injuries sustained while at LNLC. Because the Participant is a minor, this Release and Hold Harmless Agreement shall be executed by a parent or legal guardian, and shall be binding upon said parent or legal guardian as well as upon the participating minor. Said parent or guardian by the execution hereof, waives all claims to their individual or derivative capacity, as well as claim on behalf of the Participant.*

*Participant expressly agrees that the Release and Hold Harmless Agreement is intended to be as broad and inclusive as permitted by the laws of the State of North Carolina, and that if any portion is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.*
